FOR THE MIND-- WE PROVIDED HOMEWORK HELP, TUTORING, LANGUAGE AND READING LITERACY PROGRAMS AND OUR CHILDREN GREW ACADEMICALLY. 95% OF OUR K-12 STUDENTS PASSED ALL CLASSES, 77% EARNED ALL ABC'S. 100% OF OUR HIGH SCHOOL SENIORS GRADUATED AND 90 PERCENT ENROLLED IN COLLEGE OR A TECHNICAL SCHOOL.
